

District Recaps 2010 Financials

Florida-Georgia District leadership confronted budget challenges during the fiscal year ending January 31, 2011, as unrestricted support from congregations came in under projections. Those challenges were successfully met with reductions in spending and other program adjustments.

"The Florida-Georgia District staff is working hard to be the best stewards of the resources provided by our congregations," said District President Greg Walton. "We are exceedingly grateful for your participation and support, and we thank our gracious God for the faithful support the District received.

"A number of congregations contributed over and above their commitments to help in these difficult times," Walton continued.

"We recognize that the ministries God has commanded us to do can only be accomplished if we continue to walk together."

Support from congregations in the last fiscal year totaled \$2,135,277, which is a decrease of \$189,617 compared to the prior year. Approximately 23% of Florida-Georgia congregations did not provide financial support to the District during the last fiscal year.

Uses of Congregational Support

District budget priorities include missions, congregational services and school ministries. *Missions*

- Supported 28 mission sites in 2011.
- Start up of 57 missions and ministry over the past 10 years. (Mission Advisory Council goal is to start one or more new missions annually.)
- Campus Ministry mission support at four universities; new initiative to recruit campus

In Memoriam: Rev. Dr. David P. Mulder

Ascension - Casselberry senior pastor, The Rev. Dr. David P. Mulder died on May 1, 2011 – his 66th birthday

— after a brief, intense battle with cancer.

A 1978 graduate of Concordia Theological Seminary-Fort Wayne, Dr. Mulder's career encompassed service as a parish pastor, District president, publishing executive, author and military chaplain.

Dr. Mulder was president of the LCMS New England District from 1985-1991. He served as executive

vice president of Concordia Publishing House for the next three years before returning to parish ministry in St. Louis until 1998.

From 1998 to 2003, he was on the staff of the former LCMS Board for District and Congregational Services, serving as director of Outreach Ministry. He was an essayist at the 2001 LCMS synodical convention.

Dr. Mulder served with the U.S. Army in Vietnam, and later was a chaplain (with the rank of Major) in


the U.S. Army Reserve. He received The Army Commendation Medal for his work in support of reservists being sent to Operation Desert Storm in 1991. In 1996, Concordia Publishing House published his book, "Narrative Preaching - Stories from the Pulpit."

He received a Doctor of Ministry degree in preaching in 2000 from Aquinas Institute of Theology in St. Louis. The Servus Ecclesiae Christi

award was granted to him by Concordia Theological Seminary, Fort Wayne, IN.

A native of Imlay, MI, Dr. Mulder and his wife, Mary Jo, a personal chef and stained glass artist, were married in October of 1965. In addition to his wife, survivors include daughters Tara and Audra, grandson Nathanael, three brothers and two sisters.

A memorial service was celebrated on May 8 at Ascension-Casselberry.

Thrivent Financial Expands Disaster Response

Due to the widespread tornado, storm and flood damage this spring, Thrivent Financial for Lutherans has expanded its national disaster response funding. This funding now applies to any state in which the four major Lutheran disaster response organizations are providing support.

Thrivent Financial previously announced it would provide up to \$250,000 to supplement funding raised through Thrivent Financial chapter service teams for relief to assist victims of tornadoes that struck Alabama, Mississippi, Georgia and Tennessee. Thrivent Financial funding will now be used to support relief work in other disaster areas as well.

For every \$2 raised by chapter service teams (individuals from at least six separate Thrivent Financial member families), Thrivent Financial will provide an additional \$1, up to a total of \$250,000. Through this effort, a total of up to \$750,000 (\$250,000 from Thrivent Financial and \$500,000 from member appeals, collections or fundraising) will be created for disaster recovery.

The funds will be distributed to the four major Lutheran relief organizations: LCMS World Relief and Human Care, Lutheran Disaster Response (LDR), ELCA Disaster Response and WELS Christian Aid and Relief.

The deadline for the disaster response has been extended to August 1, 2011.

"Remember the Sabbath day, to keep it holy. What does this mean? Answer: We should fear and love God, and so we should not despise His Word and the preaching of the same, but deem

families, as Moms and Dads proudly watch their children move forward in life.

Life is filled with transitions!



In late May, my oldest son, Alex, married the love of his life, Angie. I remember taking him to the first day of Kindergarten as if it were yesterday, holding his hand and walking him to his classroom. I remember how heartbroken I was when he said to me after about a week of this, "Dad, you don't need to walk me in anymore. I'm a big boy." I never was quite sure if I was doing it for him or me!

Now he's a more than a big boy. He's a man, about to embark on

as God worked through His people, now more fully committed to the Risen Jesus. The Church, birthed with tongues of fire, saw phenomenal growth. St. Luke writes, "They Worship was a main value of devoted themselves to the apostles'

teaching and to the fellowship, to the breaking of bread and to prayer. Everyone was filled with awe, and many wonders and miraculous signs were done by the apostles. All the believers were together and had everything in common. Selling their possessions and goods, they gave to anyone as he had need. Every day they continued to meet together in the temple courts. They broke bread it holy and gladly hear and learn it." [Tappert, (2000, ©1959)]. Even among our own members, the level of commitment to worship is weak.

the early church. Fellowship was such an important part of the life of God's early Church — and not your typical Lutheran coffee and cake kind of fellowship. We're talking about authentic and deeply formed relationships that built into one another's lives. This is the "Life Together" that President Matt Harrison has held before us as a Synod. It is shared values and faith that strengthens our commitment

to one another at all times and in every situation. It's about knowing and being known, caring and being cared for both within and outside the family of faith. Luke indicates a strong level of unity among believers so that everyone made sure that no one was left out.

Who wouldn't want to be part of something like that?

Here's the key. They met together regularly, both in the temple courts in and their homes. This is how this fellowship is built by spending time together. Now, I don't mean just occupying the same space at the same time. Instead, they were intentional about growing in Jesus and growing together as His people. I think they understood that not only did they did need one another in an otherwise hostile environment, but their witness for Jesus was stronger as they stood together in unity, and they had to learn to do that by learning to know each other.

I've learned that this often involves practicing confession and absolution. It also involves the breaking of bread. Certainly the people ate together, but I don't believe that's what Luke was talking about. On the road to Emmaus the disciples recognized Jesus in the breaking of bread. This was a regular practice of that early Christian Community, inviting

the risen Jesus to be with them in intimate communion as they partook of His very body and blood in the bread and wine! We are still privileged to do that even today as

we gather at the Altar to receive this precious gift!

The result of this transitory time was that the church grew. In fact, it grew at an incredible rate. Years ago we raised blueberries. While the bushes started out rather slow, after a few short

blueberries, and by the time you finished more had grown and you could almost start picking again.

This is kind of the picture I get with the early church. They saw such growth because they were eager to share and people were eager to listen! Despite what we

may think, the only difference between now and then is that today the church isn't quite as eager to share, and we think that the world is no longer eager to hear! The truth is, the world is more eager than ever; however, they are looking for authentic and committed believers who live what they believe.

Perhaps this is the very transition that God is pointing His church to in our day. Spring transitions into Summer, but maybe this is the time that our ministries need to examine themselves to transition into fruitful ministries for Jesus! When our focus is on worshipping Jesus around Word and Sacrament, building accountable and deeper relationships through fellowship, when we are in prayer for others and with others, praising God, not only seeing, but proclaiming His blessings, I believe we will see many added to the church for the sake of Jesus!

May God bless that in your life in these transitional days as we continue to walk boldly together in Jesus!

On the first Saturday of the month from October until April, Christ Lutheran-Avon Park, FL, sponsors a Drive- or Fly-in Breakfast.

In 2005, Christ Church planned to purchase a nine-acre orange grove. A church would be built on part of the

property, with the rest developed for housing, leaving the congregation debt free. A Lutheran Church Extension Fund loan enabled the congregation to purchase the land and build the church.

Then the economy took a downturn.

Instead of developing the remainder of the property, the church entered into a lease agreement with the grove, providing some income. Additional LCEF assistance enabled the congregation to take some time to determine what other ways they could continue to meet financial obligations.

When the opportunity to provide breakfast to the pilots and the community opened up, members of Christ stepped up. They took the breakfast to the next level by providing homecooked casseroles



Good Shepherd-Gainesville Culminates Successful Month Of Stewardship Campaigns

A variety of capital stewardship campaign events came to fruition during May for Good Shepherd/ Gainesville, Georgia. The congregation had decided to have a DVD

produced for their campaign that would highlight all of their ministries in a way that, with only minor editing, could be used as a general "getting-to-know-us" video after completion of the campaign.

"The launch of the campaign video was held at two homes where campaign leaders and pacesetters gathered on a

Friday in May and then the video was shown to the entire congregation the following Sunday," explains Doug Fuge, campaign director. "Our initial commitment event was an evening vesper service conducted in the parking lot facing 'the hill' that will be transformed into new education, administration and fellowship facilities. Upon completion

of the service, we adjourned to the fellowship hall for refreshments while the commitments were totaled."

The response of congregational leaders and pacesetters during

the initial commitment event was approximately 85% of Good Shepherd's goal — indicating that the Lord had bigger plans than they had predicted.

By the commitment celebration on May 22, the congregation had committed \$640,000 — or about 128% of what they had considered a challenging but achievable goal.

Good Shepherd had worked with a professional consultant to establish a brokerage account for the purpose of receiving donations of securities and immediately liquidating them

to cash. They also enlisted in the Joyful Response service available from Lutheran Church Extension Fund to enable interested members to fulfill their commitments through electronic funds transfers to Good Shepherd's Steward Account.

As the fulfillment director and her team began to keep the campaign alive

through continued feedback to members and integration of new members, the building committee refined details of Good Shepherd's Phase I Expansion, while the finance committee defined the financial plan and application for a construction loan.

- District executive staff members continue to interact with the "people in the pews" through congregational visits.
- Transforming Congregations Network leaders Pastors Ron Biel and Scott Gress are working with congregations throughout the District. A modified TCN process has been proposed for small congregations.
- During this year's National Lutheran Schools Week five school students were baptized at Our Savior-Plantation, FL. In the past decade 80-plus District children have

been baptized during the event. *Critical Target: Outreach*


- Presented for future discussion: international mission opportunities coordinted by the District.

and gifts received. Generally they fund specific projects or needs and are not utilized for ongoing ministries.

Investment income from endowment funds is the exception as said income is utilized for the donor restricted purposes such as to partially fund student aid.

The total change in Net Assets for the fiscal year was an increase of \$642,064 compared to an increase


of \$89,691 for the year ended January 31, 2010. This variance is largely due to the sale and financial consolidation of the Woodlands Camp properties into the

and the percentage change of the District's commitment.

The reduction in Missions is primarily due to a reduction in mission grants awarded. This includes \$111,789 spent in the TCN Program during the year. The commitment to this program reflects leadership's conviction that revitalized congregations will do more effective mission work and better support the

work of the District. ministries and services.

Should funding levels continue to decline, the District will face the undesirable task of determining which ministries and services should be discontinued. The Board and District staff closely monitor operations and will make necessary adjustments to control any potential shortfall.



District financials. This change in Net Assets would have been larger had the District not taken write downs for the change in the Fair Market Valuations of properties totaling \$665,127.

Market fluctuations in restricted contributions receivable from split-interest agreements and permanently restricted funds held by a third-party trustee had a positive combined net variance of \$3,540. The total change in unrestricted net assets was a gain of \$921,392 versus a loss of \$330,956 for 2010. This gain is almost solely due to the sale and consolidation of the Woodlands properties.

Total expenses for 2010 were \$3,400,455 versus \$3,578,960 for 2009, or a reduction of \$178,505.

"We continually strive to use good stewardship principles and to manage revenues and expenditures in a manner that benefits and supports ongoing ministry," said Walton.

In 2009 and 2008, the District contributed to the Synod 20% of unrestricted revenues from congregations. In 2010, the District contributed 15% of that revenue to the Synod. The variance is related to the change in congregational support

President Greg Walton Offers A Persp

The May 2011 issue of *The Lutheran Witness* is about funding and making the needs known among LCMS membership. Like many of its Districts, the Synod has noticed a decrease in

regular funding. While there various reasons, I want to make sure Florida-Georgia District members understand the significant decrease in our Synodical pledge from last year to this current year.

The District pledge to Synod is based on a percentage of funds that come from our congregations. District funds result from congregations' generosity

and faithfulness representing our partnership as members of the LCMS in the District. We don't sell Bibles or Luther's Works or anything else to raise capital. In this issue of *Lutheran LIFE* you will see a chart similar to the one of published in *LW* listing District congregations and their giving in the past year. I've been asked if we do this to embar-

rass or harass congregations. Absolutely not. Our goal is to be completely transparent and help you understand how funds are contributed. Our budget is based on the funds you send to us.

Three years ago our District pledge to Synod was 20% of income based on congregational pledges. Unfortunately, the District had to borrow more than \$300,000

from LCEF to honor our LCMS pledge due to congregations' inability to fulfill their commitments to District. I felt obligated to fulfill our LCMS pledge even though it would have been easier to try to write it off and try harder the next year. As a

> new District President, my recommendation to our Board of Directors was to set our pledge to Synod at 15% so that could honor what we pledged without compromising the integrity the District budget and forcing us into further debt.

My thinking was that in order to move the District forward it first had to stabilize. Last year not only did we repay our LCEF debt, but our Synodical offering was given regularly each month. The Board reluctantly agreed as we set that budget since it was still greater than a tithe. This past year we again experienced reduction in our overall budget from \$2.6 million in 2009 to \$2.3 million in 2010 to \$2.1 million this year. While we have worked hard to maintain our mission budget, we reduced our workforce and made changes to work more efficiently. However, we can only allocate the funds that come to us.

In this year's budget, with all the changes in the LCMS's structure, the District BOD decided to make a further cut, from 15% of the overall contributions received to 12%, so that we could assist some programs that Synod determined it would no longer fund, specifically Transforming Churches Network, which our 2009 Convention directed us to support. With LCMS restructuring, more and more responsibility for services and programs is being put back on the District, as we, at the same time, deal with decreased funding.

The figure in *The Lutheran Witness* reflects not only this reduction, but also lower restricted giving — funds that come through the District that are given for specific purposes. While we don't have much control over when these funds come in, overall giving to Synod is impacted. Also, many congregations have opted to directly support ministries and no longer send funds to the District or the Synod.

As District Business Manager John Elliott explained it: The Board of Directors in their January 2011 meeting changed the originally budgeted pledge to Synod of 15% of Congregational Support (\$322,500) to 12% (\$258,000). Resultant dollars from that 3% change were split almost evenly between support for TCN National and for other District congregational revitalization efforts. Had the BOD not made this change, the pledge recorded at Synod would have been \$322,500. The \$87,000 pledge decrease (25.2%) reported by Synod is the difference between last year's pledge of \$345,000 and this year's pledge of \$258,000. The \$87,000 decrease is accounted for as follows:

John also noted that as of April 30, Congregational Support is about \$72,000 behind budget. Accordingly, we are behind budget in all major areas of giving.

I want to assure you that we are concerned about this and agree that it is something that we need to continually address not only on a Synodical level, but on a District, and more importantly on a congregational level. Your giving, as a congregational member and as a congregation, is what enables the Florida-Georgia District to support the work of the Synod.

Consider this: Lutheran Witness states that there are currently 62,450 members in the Florida-Georgia District. Our budget is \$2.1 million. If every member made an annual contribution of \$33.63 we would meet our budget. If every member contributed only \$50 per year, or less than \$1 per week — we would have a surplus! Imagine the ministry we could accomplish for the sake of Jesus Christ, and the lives that could be touched by His love and grace, if people gave \$100 annually! That's less than \$2 per member per week!

We need to understand that this isn't really a money issue, it's a stewardship issue.

We, who have been saved by grace through faith, forgiven so freely of all of our sins through the death and resurrection of Jesus, are called

Test me in this," says the LORD
Almighty, "and see if I will not throw open the floodgates of heaven and pour out so much blessing that you will not have enough room for it." (Mal. 3:10)

to be good stewards of God's resources. If we honor Him, His promise is to honor us and enable us to do the ministry He's called us to do!

So we work together to further the Kingdom of God in the best way we can with the resources we have, even as your congregation works to promote the name of Jesus with limitations that we put in place despite God's rich blessings.

I've received comments from people across our District who were alarmed by the statistic published in *LW*. Perhaps it is good for us to be shocked so that we stop and consider how to be part of the solution. While I don't apologize for the difficult deci-

sions we are making, I do apologize for any disappointment we have created. I promise you, we are doing the best we can with the resources God provides.

Together, as God's stewards, we can change this! All it takes is a little faith and some commitment to work together for the Kingdom as we examine ourselves in light of the Cross of Jesus and do what we can for Him, who gave His all for us! Yes, there are economic stresses on all of us. This is the time Jesus is looking for us to trust Him

and to be His stewards, for the sake of your congregation, for the sake of our District and the Synod, but mostly for the sake of God's Kingdom.

2011 District Work Program Highlights

Summarized by Greg Walton

- 1. Congregation support is budgeted at \$2,125,000. Congregation support for 2010 was \$2,135,277.
- 2. Fan Into Flame revenue budgeted at \$125,000. The sources of these funds are primarily known based upon an analysis of pledges.
- 3. Synodical support budgeted at 12% of unrestricted support from congregations. This decision by the Board to reduce commitment to Synod was difficult, but it produced a decision to set aside 3% of unrestricted support to be divided among support for TCN National and other District revitalization efforts.
- 4. We continue to look forward to rebuilding our support to Synod to 20% or higher.
- 5. Mission support remains at \$600,000 and supports 28 District missions. A Missions Advisory Council assists staff in evaluating and monitoring the various missions. A system of reporting and accountability has been established for each one.
- 6. TCN costs are budgeted at \$134,000, most of which will be funded by a Thrivent grant, District's commitment and an anonymous gift. Most of these dollars are budgeted for coaching

professional church workers of participating congregations.

7. We are providing a work program for 2011 that is fiscally responsible and within our funding outlook. The goal is to maintain current District ministries and services. In the event that funding levels continue to decline, we will face the undesirable task of determining which ministries and services should be discontinued. The Board and District staff closely monitor operations and will make necessary adjustments to control any potential shortfall.

For a year they traveled to local soup kitchens, Children's Miracle Network Hospitals, Ronald McDonald Houses, women's shelters, volunteer outreach programs, low-income day

care centers and teen centers to distribute the book. Some of the donations were sent overseas to U.S. troops.

"One of the soup kitchens we visit weekly is our sister church, Christ Lutheran in Perry Georgia," said Mrs. Peterson. "Pastor John Lehenbauer, with the help of Perry Volunteer Outreach, loaned us a room in the Loaves and Fishes Food Pantry building.

"We set up a small library in November 2010. We are very blessed to say we have more than 10,000

books in our library!"

Of the 25-plus categories of books, the most popular "by far" is the religious section, according the Petersons.

"While patrons are waiting to get their food basket they come into our library and browse. We like to say Loaves and Fishes feeds their body and we feed their soul," Mrs. Peterson added.

"Every day people come in wanting Bibles -- we never can keep

them on our shelf Most of the time we have to tell them that we have run out."

Taylor, who will enter 10th grade in the fall, is the reigning Miss Southern Heartland's Outstanding Teen and will be competing at Miss Georgia this June. She is active in Mount Calvary's youth group along with volunteering in the nursery and occasionally playing the piano during the offertory.

Their mission is simple: to establish relationships with large food suppliers and distribute food through nonprofit agencies throughout the country.

In the case of LSS-

Jacksonville, food is distributed to 18 North Florida counties through Second Harvest North Florida. When LSS was incorporated in 1979 by a consortium of Lutheran churches and Jacksonville community leaders, its first program was the Nourishment Network. That small food pantry has now grown to become the only food bank in this region — Second Harvest North Florida.

The national political debate over budget issues reminds us that, regardless of personal political persuasion, our Christian mission as congregations and as individuals to "feed the hungry" in the name of Jesus (Matthew 25) yet remains.

You can participate in this on-going ministry of human care.

Two actions can be taken:

A congregation can establish a relationship with a local food bank and regularly gather groceries for

that food bank, which, in turn, will distribute that food to various community agencies and into the stomachs of hungry kids and families. To find your local food bank, go to FeedingAmerica.org and type in your zip code as indicated. FeedingAmerica.org can also connect you to other programs that assist in feeding low-income individuals and families with the fuel to survive and even thrive.

An individual can participate in efforts such as the annual "Stamp Out Hunger" Food Drive, the largest one-day food drive in the United States. It is held annually on Mother's Day weekend. Residents are asked to leave nonperishable food donations in bags or boxes by their mailboxes. The donated food is picked up by USPS letter-carriers and delivered to a variety of local non-profits who feed hungry kids. The National Association of Letter sponsors the food drive in conjunction with major food distribution corporations.

Be on the look-out for opportunities to feed hungry kids in your area. Know that we are called for ministries such as this, congregations and individuals alike.



- In addition to donating a large quantity of clothing, they folded and organized all of the donated clothing.
- A new shelf was built for the clothing room.
- The sanctuary was cleaned and given a bright, fresh coat of paint.
- The computer room was painted.
- Trees were trimmed, leaves were rakes, chairs and carpets were shampooed.
- The front of the building was painted.

"This will be an exceptionally long-term recovery," said Rev. Glenn Merritt, director of the Lutheran Church – Missouri Synod's Disaster Response and a former police officer. "The situation in Joplin is much more intense because so many infrastructures have been destroyed, so many homes, apartments, churches, schools and businesses."

Tolerating Evil Not a Virtue by Bruce Lieske, Lutherans in Jewish Evangelism

Is tolerance a Virtue? Yes and no.

The question is tricky. Our culture tends to affirm "tolerance" as a virtue, an attribute of good people. In Los Angeles there is the Museum of Tolerance which addresses the issues of prejudice and racism, with a special emphasis on the Holocaust. The museum is visited annually by more than 300,000 children -- a concerted community attempt to overcome attitudes of racism and prejudice.

But what did Nobel laureate Thomas Mann mean when he said, "Tolerance becomes a crime when applied to evil"? Mann, an antifascist, fled to the United States when Nazism (National Socialism) gained a grip on his German homeland. Earlier this year Muslim terrorists infiltrated the home of Udi and Ruth Fogel in Itamar, Israel, and slit the throat of

the Fogel's 11-year old Yoav as he was reading in bed; stabbed his 4-year old brother, Elad, twice in the heart; then knifed Ruth as she came out of the bathroom; killed Ruth's sleeping husband; and completed their "mission" by mortally stabbing the infant daughter, Hadas.

When 12-year old Tamar came home from a youth meeting she found her 2-year old brother, Yishai, shaking his parents' bodies and crying for them to wake up. Where does this kind of evil come from? How can a human deliberately butcher a sleeping baby or plunge a knife into a toddler's heart?

There is a worse evil. As news of the March 2011 massacre in Itamar spread, young men in Gaza distributed candy and pastries in celebration. They expressed not only tolerance, but affirmation.

How did Nazism (National

Socialism) gain a grip on Europe in the last century? And today, how is it possible that radical Islam has gained a grip on many countries? Some say it has even gained a foothold in the United States. It is possible to happen when good men -- and women -- tolerate evil ideas. St. Paul, writing to Christians in Rome, said: "Do not be overcome by evil, but overcome evil by good." (Romans 12:21)

We can overcome the evil political-religious ideas of radical Islam by God's good words! Let us draw strength and courage from God's Word: "For God did not give us a spirit of cowardice, but rather a spirit of power and of love and of selfdiscipline." (2 Timothy 1:7)






