"Jesus was always building relationships with people...now that is our job," Walton said.


"We are called not to reach out to those in the church but to those outside its walls."

Referencing Jesus' sermon on the mount, Brighton reminded worshipers that "you are the light of the world" and encouraged them to "let your light shine before men."

He continued, "We are equipped to do the Master's business. Jesus is the light of the world; He came to point the way to the Father. He calls upon us to go out in His name to seek and to save the lost."

devotion. What would it look like,
Kneser wondered, if Jesus texted

RYB & PTL — Read your Bible & praise
the Lord

EMB — Engage in the Master's Business!

Preaching at Sunday's communion worship, Walton returned to the parable in Luke 19 that served as the Gospel message.

"We are called by Him...called and empowered to engage in His business," Walton said. "We have the pure oxygen of the Gospel, but are we sharing it?

"We are called to shatter the darkness with the light of Christ... to move beyond the walls of our churches to where people are — to reach the world before it is too late."

Walton encouraged and challenged worshippers, "Jesus

loves you so deeply... How will you use your minas? He has equipped us to engage in His business."

Hope / Plant City Director of Music Christine Mansell provided keyboard accompaniment for hymn singing throughout the Convention. Charles Crownover directed the praise team from Woodlands during Sunday morning worship.

Editor's note — President Walton's column this issue is an excerpt from his Acceptance Speech given at the 2015 District Convention.

I am deeply humbled and honored to have your support to serve another term as the President of the Florida-Georgia District. It was never really in my plans to serve in this way, to be honest ... still, the Lord has used the Florida-Georgia District to shape my life and ministry for almost 30 years, and I am proud to serve this District as the District President.

Your investment in me, your trust, is very important. Often I am faced with impossible decisions that impact lives, and people look to me as if I have the wisdom of Solomon. The truth is, while I have learned a great deal over the past six years, I've learned to be a man of prayer, learning to trust the Lord. Sometimes I get it right, and sometimes I simply struggle to know what's right.

Like each of you, I cling to God's grace in Jesus and do my best, which sometimes leaves someone disappointed. My desire is always to work toward reconciliation and to bring the peace of Jesus to the workers and congregations of our District. I want you to know that this isn't always easy. However, I am committed to working toward that end.

I have also learned that I have to be intentional about my family life, even as I encourage all our workers to be. I am grateful for Edith, for her patience, for her willingness to travel with me, for her ministry to me and to the ministries we visit. It is far too easy to be consumed by the never ending tasks of ministry and to allow my priorities to get out of

balance. While it is my privilege to serve this District, God has given to me my wife and children, and now my granddaughter, as very special gifts and as the first order of priority. I made my commitment to Edith before I was ordained, and I take that vow seriously. There are times, when because of schedule I'm away from home, sometimes for weeks at a time. Edith understands that. However, there will be days when I'm away from the District to be with her, or to be with my children. Brothers and sisters, DO NOT neglect family or family commitments. I will continue to strive for this in my own life and family.



As we look to the next triennium, the focus in the District will be on outreach. Of course, this has always been the mission focus of this District, but we want to devote additional energy and resource to reaching out.

This is a critical target for the District and, in part, why we have partnered with Lutheran Hour Ministries, among others. The need around us is so urgent. The Church (with a big C) seems to be losing so much ground, and many of our District congregations are seeing members disappear and attendance slip for a variety of reasons.

Here's what I know: If we want to see the church grow it begins with investing in, and developing, relationships with people. I do not advocate compromising our doctrinal positions or our historical heritage. I believe that we must stop expending so much effort on protecting our doctrine and heritage and simply start living

it out as we live in the world as Lutheran Christians.

We talk a lot about what we believe, and we're good at this. But the world around us already looks suspiciously at the church, feels we're hypocritical and that our words don't often match our actions, and really doesn't care what we say. What good does it profit a man if he can proclaim with clarity the truth but doesn't reflect it in how he lives it out?

If we're to survive in this current day as the church, and we have so much to offer to the world in Jesus, then we can't simply hide away in our churches and hope that people will come to us and adapt to our traditions. We need to bring them to the truth, but it requires that we DO something to reach them! It means moving into the community incarnationally!

What if we simply made the effort to intentionally build relationships with people all around us, whether at work or at the gym, in school, in the grocery store? What if we actually invested the time and energy into caring about others more than ourselves, more than our customs, more than our programs, even more than our buildings?

Customs, programs and buildings won't draw people to Jesus. You and I are the ones chosen by Jesus to draw people to Him by the Holy Spirit working in us. Jesus said, "You did not choose Me, but I chose you to go and bear fruit, fruit that will last..."

What are you known for in your community in a positive way? Many a church in our day has gained notoriety for a bad reputation, but that's not what we're looking for.

In the early Christian community, Tertullian reported that the Romans

would see the Christians and exclaim, "See how they love one another!" The love of the early Christian Church wasn't limited simply to their fellow believers. Christians also lovingly helped nonbelievers: the poor, the orphans, the elderly, the sick, the shipwrecked — even their persecutors.

In Matthew 5, Jesus said, "Love your enemies . . . and pray for those who spitefully use you and persecute you." The early Christians accepted this statement as a command from their Lord rather than as an ideal that couldn't be actually practiced in real life. What kind of impact do you think we would have on our neighborhoods if we actually made strides to live this out and love people like Jesus?

In the next five to six years I hope to hear of the wonderful things our congregations are doing in their communities as they engage in the Master's business and connect people to Jesus. I pray that we'll see people from our congregations building relationships in their community and congregations gaining the reputation of being loving, caring communities of believers.

I believe we'll see stronger leadership, not only among our professional church workers but also among our laity. I believe we will continue to see congregations grow as they reach people, one at a time, and share the love of Jesus in ways that draw them to the foot of the cross.

We can make a difference, every one of us. I pray that the Holy Spirit would move in our hearts in such a way that we find a greater way to blend our traditions and the legacy that belongs to the Lutheran Church with our being more mission minded,

focused intentionally on outreach, connecting people to Jesus.



We have such a tremendous history in the Florida-Georgia District for the past 67 years as being mission minded, reaching into a variety of ethnicities and cultures, sharing the overwhelming forgiveness and love of Jesus, engaging in the Master's business. When we gather again in 2018, we will celebrate our 70th Anniversary as a District — no small feat.

I can think of no mission congregation that began with the thought and hope of becoming an exclusive country club community, open only to those who meet strict requirements. Instead, almost every one of our congregations began with a deep passion to share the faith in Jesus that claimed us as God's own. Missionary people recognized that we are a chosen people, a royal priesthood, a holy nation, a people belonging to God so that we can declare the praises of Him who called us out of darkness into His marvelous light.

There is still much to do, and I am proud to lead the charge to serve, assist and encourage this District, along with my very capable staff, as we seek to equip, empower and engage to connect people to Jesus. I thank you for this trust, but I ask for your partnership, your support, your patience and your prayers.

Together we are stronger and far more capable to have an impact on hearts and lives for Jesus. We are the Florida-Georgia District, some 200 plus ministries, some 6,000 plus people, covering a third of the Eastern Seaboard, walking together as Synod in this very special and wonderful place we call home, committed to proclaiming Jesus through Word and Sacrament, and sharing His love with all in need.

God will continue to bless our work in His harvest field, and He will continue to open opportunities before us, as we keep our eyes on Jesus. It's all about Jesus and the difference we know He makes in the lives of sinful people.

May we together commit ourselves, as we look toward our 70th Anniversary, to engage in the Master's business—connecting people to Jesus!

High Agreement Characterizes Most Convention Resolution

All resolutions presented by four floor committees - Leadership, Congregations, Outreach, Bylaws were presented to and approved by the 2015 Florida-Georgia Convention delegates.

Two Leadership resolutions generated the most discussion:

• To support the establishment of a new collaborative Lay Deacon Program (passed by 72.6% after being tabled during initial discussion and returned to the floor by the committee). With its adoption, delegates affirmed that the Florida-Georgia District express its support

for the Concordia College-New York's new lay leadership or Certified/ Licensed Lay Deacon program as a collaborative means of raising up new lay leaders; and that congregations be encouraged to participate in the program.

• Recommend Moving Synod to Four-Year Convention Cycle passed by a 50.3% vote. With its passage, this resolution will be sent to national Synod for possible consideration at next year's LCMS Convention.

Delegates approved by a 94% margin the establishment of a Florida-Georgia young adult

network, resolving that the District provide necessary resources and guidance of this structure.

A Congregations resolution to establish an Operation Barnabas Task Force and encourage circuit and congregational support and participation passed by 99.5%. Another Congregations resolution was to encourage congregational stewardship; it was adopted by a 92.9% positive vote.

An Outreach resolution affirming the District's Outreach Initiatives passed by a 95.5% vote, "strongly" encouraging Florida-Georgia

congregations and schools "to develop outreach plans for their ministry over the next year and begin to implement them on or before June 2016."

Delegates affirmed Church Planting in the Florida-Georgia District by a 96.5% aye vote, encouraging congregations to conduct annual appeals for church planting and to pray for workers who will focus on new ministry starts.

Lois Ford, Bill Gaik and Pat O'Brien Honored as **Servants of Christ**

Among the enduring Florida-Georgia District Convention traditions is the presentation of the Doulos tou Christo — Servant of Christ — award to a Commissioned Minister of Religion, a layperson and an ordained minister.

This year's recipients have served in a wide variety of congregational, regional and District capacities for decades.

Commissioned Minister Lois Ford has been teaching in the Florida-Georgia District for 39 years —21 years at St. John / Ocala and for the past 18 years at Faith / Eustis. She was re-elected to her second term on the District's Board of Directors at the Convention; she also chairs the District Scholarship Committee. A former Florida-Georgia LWML President, Ford is website editor for the auxiliary.

Layperson William Gaik, a member of Trinity / Toccoa, has been in the District since he was 10 years old. With this Convention he completed his full term of service on the Board of Directors as a regional lay representative and a member of the finance committee. He was elected to the Synod Commission on Nominations during the Convention. Gaik's service to his church is a family tradition: his father was also awarded the Doulos

tou Christo award. Ordained Minister Pat F.A. O'Brien came to the Florida-Georgia District in 1982 as pastor of First / Clearwater, where he served until his retirement in 2006. O'Brien has been on various Circuit, District and Synodical committees and was instrumental in writing the manual for circuit counselors. He served on the District Board of Directors for 12 years, nine of them as secretary, and has been parliamentarian for the past two District conventions. He is a member of the District Constitutions & Bylaws Committee

and an adjunct member of the District President's staff.



Florida-Georgia District Financial Highlights For Fiscal Year Ending January 31, 2015

Greetings in the name of our Lord and Savior Jesus Christ!

It is with thanksgiving for your partnership in the Gospel that I offer up the following summary of The Florida-Georgia District Financials for FYE January 31, 2015.

Congregation Support increased from \$2.14M to \$2.76M year over year. While that increase is wonderful, we note that \$665,708 of that support came from the closing of Redeemer Lutheran/Miami, FL. If we remove that portion of funding from the overall number, congregation support from active congregations actually decreased by \$42,755 year over year.

The District continues to operate with no real debt and all restricted net assets are fully funded. Having all restricted funds fully funded gives us the opportunity to act quickly when the Lord presents opportunities for new missions. Overall I am pleased to report that expenses are being kept in check. and we have just about two months of operating expenses in the bank.

Statement of Activities

Unrestricted support from congregations totaled \$2,784,763. Net assets released from restriction increased by \$22,973 year over year. These assets released from restriction fund specific projects or needs and are not utilized to fund

> ongoing operations or ministries. Their usage is determined by project need or donor restriction. Accordingly, their usage can vary greatly from year to year.

There is a change this year in the reporting of income and expenses. In prior years we netted the LCEF program income against Mission and Ministry Support expenses. This year the LCEF Program Income and the total Mission and Ministry Support expenses are fully expressed on both the income and expense sides of the Statement of Activities. Total expenses for FYE 2015 were \$3,258,444 versus \$3,080,006 for FYE 2014, or an increase of \$178,438. Most of this change is due to the increase of our tithe to Synod (\$133.245) and the increase of the Preparing Church Workers expense (\$25,272) which is mainly due to the launch of the District

Emergent Leader program. Convention, Conference and Workshop income is expended under the Congregational Services expense line items. The decrease in this expense line mainly due to staff retirement. We continually strive to model good stewardship with the funds you have entrusted to us and use them in a manner that meaningfully benefits and supports ongoing ministry.

The District increased the tithe to Synod during the past year. During FYE 2015, 15% of all congregation

The District also tithed on the receipt of the extra funds from the closing of Redeemer Lutheran in Miami. Hence the large increase in the gifts sent to Synod.

contributions to the District were tithed to Synod.

The total change in Net Assets for the past fiscal year was an increase of \$530,188 compared to an increase of \$59,558 for the year ended January 31, 2014. This variance is mainly due to the closing of Redeemer Lutheran in Miami.


2015 Work Program

The highlights of the 2015 work program are as follows:

- · Congregation support continues to be budgeted at \$2,100,000. Fan Into Flame revenue was budgeted at \$10,000 as this program winds down.
- · Through unanimous support of the Board of Directors, Synod support was increased to 16% of congregational support. The District continues to set aside an additional 3% of unrestricted support to fund both TCN and District Revitalization efforts.
- Missions Support remains at \$600,000 and supports ten (10) approved missions throughout the District. The Missions Advisory Council continues to volunteer their talent, time and effort to assist the District staff in evaluating the various missions that are supported. The Missions budget also includes support for eight (8) other Lutheran organizations (e.g., Lutheran Services Florida and Mission Haiti).

It should be noted that the Work Program does not include revenue or expenses for Pastor and Educator Conferences or the District Convention. These conferences are zero-based budgeted, which means that they are designed to bring in as much revenue as we spend on the conference. As such, they have no impact to the overall budget picture and are not included here. We believe it brings more clarity to how much is being spent in the ministry areas of the District.

Thrivent's national board of directors appointed these first six board members, who come to the table with a wide variety of backgrounds and skill sets. In time, members in the region will have the opportunity to elect them.

Taking Action

Thrivent Action Teams are one way members can get involved in making a difference in their communities through the Thrivent Member Network.

Here's how they work: Any member who has an idea to serve his or her community can round up a team of volunteers, go online and fill out a quick-and-easy Thrivent Action Team application. After approval, the Thrivent Action Team leader gets a start-up kit in the mail. That kit includes things like banners, invitations, a project planning checklist and T-shirts. The leader also receives seed money to help launch the project.

Karen Coombs, a member and former leader of the Martin-St. Lucie Chapter of Thrivent Financial, is excited about the simplicity of the Thrivent Member Network and Thrivent Action Teams.

"My initial response was 'Yes!' because there was so much paperwork with the chapter system," Coombs says. "People are already excited about this. It's simple, straightforward. It's just amazing."

Another happy result: "Most of these Thrivent Action Teams are

getting paired up with organizations that Thrivent has never been a part of," says Vann Doubleday. A financial representative in Savannah, Georgia, Doubleday has personally volunteered with a Thrivent Action Team supporting Coastal Pet Rescue in Savannah. "It's sparking a conversation among people who may have never heard of Thrivent. It's getting people to be more creative and encouraging generosity. The potential is huge."

How will you engage in the Master's Business? Following our Florida-Georgia Convention I hope each of us will take notice of all that God has blessed

and entrusted us with to carry out His business, bringing the good news of Jesus to others. It is all about connecting people to Jesus!

During the convention we learned that the Lord has sent some 30 million people to live within our District borders. He has established more than 200 churches, many with schools and preschools, to help

us "teach all things." Inside our District God has blessed us with more than \$2 million annually to fund His mission, and He has more than 50,000 ambassadors who are part of His world-wide mission team. They work daily in our schools, hospitals, businesses, government and homes to speak and carry out His business in their vocation.

God has called us to do two primary things: love God and love man. Paul says in Romans



13 that "love is the fulfillment of the law." Love is the main ingredient in outreach; without it all efforts are "a noisy gong or clashing cymbal ... without love it is nothing." Perhaps we have made outreach, sharing our faith way too hard. We really only need to do one thing — LOVE!



The Florida-Georgia District now has 30 million people living within its borders, with fewer than 20% attending church anywhere/ any time. I believe that God has placed our District congregations and schools here to connect people to Jesus. The pilot Outreach Initiative we have entered into with Lutheran Hour Ministries is designed to help congregations, schools and individuals engage in our Master's Business. Our District goals are by God's grace to have:

- 3,500 new believers annually who have expressed their faith through baptism, profession of faith or adult confirmation.
- Increase in worship and members engaged in Bible study in at least 50% of our congregations.
- Start 10 or more new starts in the next three years.

How will your congregation be involved? How will you be engaged in the Master's business? What goals will become a part of your

congregation's or school's outreach plan?

Barna conducted a survey of our District with more 2,000 respondents; we found that the three most common outreach



factors were culture, connection and community. A culture of outreach inside the church is critical to a congregation's efforts to go and make disciples. Sermons, newsletter articles and bulletins that communicate outreach stories and events in the congregational life are all important examples. Connection of the congregation to those who have visited or come into contact with the church and her members is also crucial. A phone

call, a visit or an email all show that "we care and you matter to us."

Community is how the congregation engages in the life of the community to bring the blessing and witness of Christ. This "C" deals

with being Christ in this place for the benefit your community. Lutheran Hour and the District have resources that deal with each of these three Cs. Go to www.lhm.org\outreachinitiative to see what new resources are available. Most have been designed by practitioners in the field.

Web based resources are available to you and members of your congregation to help you Engage in the Master's Business of connecting people to Jesus. They are free, available to you 24/7 and allow you to pick resources most useful for your ministry.

Lutheran Haven has announced the summer opening of its new Memory Support facility.

The Haven Trustees deemed this new service a top priority in

response to the growing demand for assistance for seniors suffering with Alzheimer's and other dementias. In an effort to be fiscally responsible, they have chosen to convert a building on campus through refurbishments into what is now to be called "The Lodge at Lutheran Haven."

The Lodge is a carefully designed, specialized environment with very unique amenities and will provide individualized services for seniors with a level of memory impairment that makes living at home unsafe, but who are not in need of the intensive services of a nursing facility. It is the Haven mission to serve these special seniors and their caretakers by providing a safe and secure residential environment. The Lodge will be staffed by specially trained professionals who will allow residents to maintain a level of independence within a protected and unique living environment.

The Haven is proud to be the provider of this new "safe haven" for current and future residents experiencing memory impairment and is a service designed in response to the following disturbing facts:





FLORIDA-GEORGIA DISTRICT CONVENTION 2015

Walton Returned to Third Term as President by Acclamation

Rev. Gregory S. Walton will serve as President of the Florida-Georgia District for the next triennium after being returned to office by acclamation at the 32nd Regular Convention in June.

Walton has served in the District since his 1987 ordination into the pastoral ministry, first at Trinity / Toccoa and then at Faith / Marietta. He was a member of the District Board of Directors for many years prior to assuming the president's office and is a past chairman of the Florida-Georgia Task Force on Recruitment.

"I am deeply humbled and honored to have your support to serve another term as the President of the Florida-Georgia District," Walton said in his acceptance address at the Convention.

Looking ahead to the next triennium, Walton told delegates that the District focus will be on outreach.

"This has always been the mission focus of this District," he continued, "but we want to devote additional energy and resource to reaching out. The need around us is so urgent."

Later in his address he reminded delegates of the District's "tremendous" 67-year history "as being mission minded, reaching into a variety of ethnicities and cultures, sharing the overwhelming forgiveness and love of Jesus, engaging in the Master's business" – a reference to the Convention theme.



"There is still much to do, and I am proud to lead the charge to serve, assist and encourage this District, along with my very capable staff, as we seek to equip, empower and engage to connect people to Jesus," Walton continued.

"God will continue to bless our work in His harvest field, and He will continue to open opportunities before us, as we keep our eyes on Jesus. It's all about Jesus and the difference we know He makes in the lives of sinful people."
