- 2. Minutes of Fall Meeting Lynda
- 3. Update on Glenn's Health—Mark
  - a. Glenn's health is deteriorating, and he also takes care of his wife.
  - b. The recognition dinner we were planning for June, would not work for Glenn
  - c. We will do something in the future, even if it is just Mark and a small group meeting with him somewhere.
- 4. Updates on district schools
  - a. Good Shepherd, N. Ft. Myers –extension to 2018-2019 (Boyd is consultant). Bob will report a little later.
  - b. Holy Cross, Sanford already accredited AdvancED, first application for NLSA. (Ruth is consultant) Ruth will report
  - c. Gloria Dei in Davie is closing grades 1-8 they will need to make some adaptations to their plan that will make more sense to a school that only has EC
  - d. Immanuel Brandon Provisional status approved to be removed (Wiedenmann TC) OK to be moved from provisional status. Ruth made a motion to remove the provisional status. Roger seconded. They will follow through with the team captain with the school.

  - a. Review of CAR's & Schools addressing recommendations
  - **b.** Kathy spoke with several people re: Woodlands. The director came back with several items that they didn't feel were necessary so that was good progress.
    - i. Note: As the DAC, We need to have some clarity about what a school should do with the recommendations that the team leaves with the school administration.
- 6. Continued FL-GA accreditation for Redeemer, Pensacola (Southern District) Reviewed by Glenn everything was in order. Pat moved that we accept their CAR; Ruth seconded. With no further questions, the motion carried.
- 7. Continued FL-GA accreditation of ELCA schools
  - a. Trinity, Kissimmee will address when we hear about the team visit

- b. Advent, Boca Raton Pat moved that we approve, Ruth seconded. Motion carried
- Continued accreditation of LCMS schools These are all the schools that completed their CAR – Bob Boyd – Good Shepherd in N. Ft Myers – With a visit this year we will accept their 2018 CAR. They have been submitting materials to Bob Boyd so we will grant them continuing accreditation and start again. Roger moved; Bob Boyd seconded. Motion carried.
- 9. Review of team visits for 2017-2018 (Please limit your comments to two minutes)
  - a. St. Paul, Lakeland (AdED) Leo (C) Jon was on the team used the AE protocol. Lot of good things happening. AE requires that they have some things that they are working on for improvement. Jon recommended FLGA Accreditation along with NLSA accreditation. Jim seconded. Motion carried
  - b. Trinity, Delray Beach (ECD 2 + OI and EBA 1) Karen (C) Bob and Jodi EBA; Karen will speak for Jody. A tough one. It is a good school but preparation was not well done. Recommendation that provisional accreditation be recommended with some specific things that are augmented for a more complete report. Karen: the EC also had some difficulties. They did produce the items request. EBA Provisional; ECD2 was awarded accreditation. The team did not consider them to be ready. The new principal understands that the visit was not as comprehensive as it should have been. Because of the provisional status it was made clear that improvements have to be made during the 2018-2019 when the 2019 CAR is due. Bob and Karen made their recommendations; Kathy seconded. Jamie was the assistant 5 years ago. The team believes the new administrator is more aware of the need for this to be done more thoroughly. Approved the recommendation for provisional for the school; complete for the ED
  - c. Faith, Hialeah (EBA 1) Leo (C) They were pretty much ready, but getting documents in was difficult. All their documents were in Spanish and English. They had several things on hold because they were waiting for their new pastor. They did receive a new pastor, but the man rescinded the call. Ruth said they recommended; Pat/Roger seconded. DAC approved the motion.
  - d. Holy Cross, N. Miami (EBA 1) Bob (C) Jon was the team captain. They are extremely involved in their community. Documents were late. They celebrated Haitian Flag Day. They are so involved in their community. Powerful practices. Team recommended accreditation Ruth seconded. If you call Sherri directly she will be responsible. Motion carried
  - e. Trinity, Kissimmee (EBA 1) Roger (C) Steve was captain. An all-star visit team. Located in the middle of the homeless population. Security is a concern. Quite a bit of damage from the hurricane. They were pretty well exhausted by the time it was visit time. Good visit. Steve is working with them on their school improvement plan.
  - f. Good Shepherd, Sarasota (ECD 1) Glenn (C) While the team was there for the visit, everything was in place and ready for the visit. No one had any major concerned. Techers were very engaged. It is a great team throughout the school.

- g. Messiah PS, Tampa (ECD 2 OI) Kathy (C) Pat Weigart was captain. Beautiful classroom. Four classrooms, color coded. Clean school. Teachers very engaging, materials were wonderful. Pastor was also wonderful in chapel. Lovely school. Recommendation full accreditation NLSA/Distrct. Brenda recommended accreditate Roger seconded. Motion carried
- h. Faith PS, Viera (ECD 2 OI) Karen (C) Karen had a great visit with this beautiful school. Jodi and Paly tucker. Well run; parents happy. Recommending for full accrediate. Kathy seconded. Motion carried.
- i. Grace, St. Petersburg (EBA 1) Ruth (C) Roger was captain. Good team. Had a little problem with getting the material when they wanted it. They used Drop Box rather than Goggle Docs; once they got everything properly set up it was smoother. Very positive; lot of excitement. Recommending District and NLSA. Motion carried.

Do not have an administrator for next year. In the process of hiring an interim principal. They have to get things ready for the fall conference.
  - d. Advent, Boca Raton (Consultant Sorren) Brenda team captain. Spent several hours with them. She has received some of the materials. Very willing.
  - e. St. Michael, Ft. Myers (Consultant Peterson) Jon Consultant They are using AdvancEd slightly different with new electronic interface.
  - f. St. Paul, Peachtree City (Consultant –Schweichler) Karen had a note from Jody. Tammi Worthington is going to be the chair of the accreditation team. Curriculum is well underway.
