# **Ecclesiastical Dispute Resolution and Church Autonomy**

Nothing in these Terms alters or replaces the Constitution and Bylaws of The Lutheran Church Missouri Synod or the governing documents of the Florida-Georgia District. Matters of doctrine, teaching, divine call and roster status, membership, supervision and discipline of church workers, congregational or district governance, or the interpretation or application of LCMS governing documents are ecclesiastical in nature. Such disputes are resolved exclusively within the church under the LCMS dispute resolution process set forth in LCMS Handbook Bylaw section 1.10, including reconciliation, panels, and review. Civil courts are not the forum for these disputes under the church autonomy doctrine.

Disputes arising from this Site that can be resolved by neutral principles of civil law without entanglement in doctrine or church governance, including claims relating to intellectual property, website terms, or data and privacy, may be brought in a civil court of competent jurisdiction as provided in the Governing Law and Venue section.

If a civil dispute substantially overlaps with an ecclesiastical dispute, the parties agree to stay any civil court action until the church process under Bylaw section 1.10 concludes, so that the court does not intrude into ecclesiastical questions.

The District may seek temporary injunctive or other equitable relief in civil court to protect the Site, data security, or intellectual property, without waiving church autonomy or the exclusive church forum for ecclesiastical disputes.

# **Governing Law and Venue**

These Terms are governed by the laws of the State of Florida and applicable federal law. Venue for all neutral civil disputes shall be exclusively in the state courts of Orange County, Florida or the federal courts of the Middle District of Florida, Orlando Division. By using this Site, you consent to the personal jurisdiction of these courts and waive any objection to venue or forum on grounds of inconvenience or otherwise. This provision does not apply to ecclesiastical disputes, which proceed solely under LCMS Bylaw section 1.10.
